Kanazawa City offers partial financial aid for school expenses for individuals who have trouble sending their children to an elementary school due to financial circumstances.

- (2) Guardians of children who will enter an elementary school (except special needs schools) in Kanazawa City.
- (3) Those who meet the eligibility requirements for financial aid for school expenses
 - 1) Eligibility by income level

4. Post-enrollment financial aid

- Even if you have already applied for financial aid for new school supplies, you still need to apply separately after enrollment if you wish to also receive the post-enrollment financial aid for school expenses, school lunch fees, etc. (See 2 for details)
- Those who <u>received</u> the financial aid for new school supplies are not eligible for post-enrollment financial aid for school expenses.
- If applicants qualify for post-enrollment financial aid for school expenses even though they did not receive the financial aid for new school supplies, the financial aid for new school supplies will be paid after enrollment in August.

Kanazawa City offers partial financial aid for school expenses for individuals who, due to financial circumstances, have trouble sending their children to an elementary and/or junior high school.

 - * The eligibility requirements are shown on page 1 under 2 (3). Certification based on income level is examined based on the total income for the year 2024.



3. How to apply

Information about financial aid for school expenses and an application form are provided by schools each April. Apply by the deadline specified in the information.

It is necessary to apply each year to continuing receiving the financial aid.
