

Regarding Provision of Information from the List of People Who Require Support for Evacuation

Kanazawa City keeps a List of People Who Require Support for Evacuation: a list of people who are expected to need assistance in the event of a disaster, such as people with disabilities.

Please submit the agreement regarding the provision of the list during ordinary times to the relevant people, such as welfare commissioners, etc. regarding evacuation support.

How to Complete the Agreement

1. Fill out the items in bold frames.
 * The document will be machine-read; please write within the box borders.
2. Please check ☒ either "Yes" or "No" for whether you agree to provide information for the List. If you do not agree, please check ☒ the reason(s) why.
3. Be sure to sign the name section. If you are unable to sign the document, please have a proxy write it on your behalf and stamp with your seal.
4. People living in a care facility or who have been hospitalized for three months or longer are requested to write the name of the facility or hospital in the "Living Address" section, and check ☒ "I am a long-term resident of a care facility or hospital".

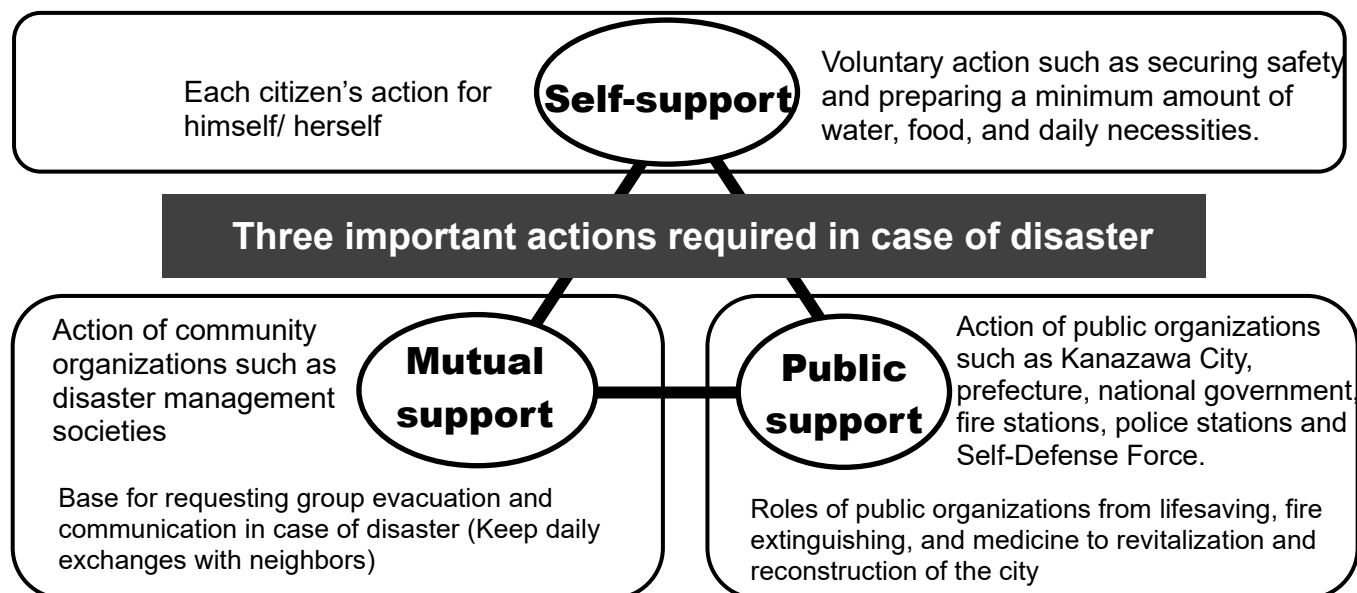
(Other Notes)

- In the event that no agreement is submitted, information will be provided to local evacuation support personnel as though a response was submitted indicating agreement to provide information, as stipulated by the Kanazawa City Ordinance and Enforcement Regulations on the List of People Who Require Support for Evacuation.
- In the event of a disaster, as stipulated by the Basic Act on Disaster Management, the list will be provided to people involved with evacuation support, regardless of whether the individuals on the list have agreed to provide their information.
- Agreeing to provide information increases the likelihood of receiving evacuation support in the event of a disaster. However, please note that depending on disaster circumstances, you may not be able to receive prompt, necessary support.

The List of People Who Require Support for Evacuation is for Mutual Community Assistance

Agreeing to provide the information of people who need assistance for evacuation to those involved with evacuation support in ordinary times allows us to help monitor such people on a regular basis and confirm their safety and evacuate them in the event of a disaster.



Who requires support for evacuation?

- People in need of nursing care: · Person who is certified for Level 3 or higher for nursing care
- Disabled people: · Person who is certified for Level 1 or 2 of disability in an upper limb, body trunk, vision or hearing
- Person who is certified for Level 1 ~ 3 of disability in a lower limb
- Person who has a rehabilitation certificate
- Other: · Other person who required support for evacuation (Application to the city is required.)

Who are people related to evacuation support?

Welfare commissioners, voluntary disaster management organizations, fire squads, regional social welfare councils and social workers.
