

Kanazawa City Accompanied Maternity Support Project

This project consists of “**Accompanied Counseling**”, which is provided consistently during pregnancy through the periods of childbirth and childcare, and “**Financial Aid (Pregnancy Subsidy)**” to mitigate financial burden.

Accompanied Maternity Support

1 At the time of pregnancy notification (at the time of issuance of the Maternity and Child Health Handbook)

You can consult about matters that are expected to occur until delivery and how to spend your time during pregnancy.

2 Around 8th month of pregnancy

The counseling questionnaire is sent to eligible women; please provide a response.

3 House visit to check the baby's condition after delivery

A health nurse will visit you by the 3rd month after childbirth. Please submit the “Home Visit Request for Babies and Mothers” (Communication Card) included in the Maternity and Child Health Handbook.

*In addition to the above, counseling is provided at any time requested.



Financial Aid (Pregnancy Subsidy)

1 Pregnancy period (1st payment)

*The application form will be provided during the consultation at the time of pregnancy notification.

50,000 yen per pregnancy

Application period:

Within two years of pregnancy confirmation

2 Post-childbirth (2nd payment)

*The notification form for the number of fetuses is provided during home visit counseling.

50,000 yen per fetus

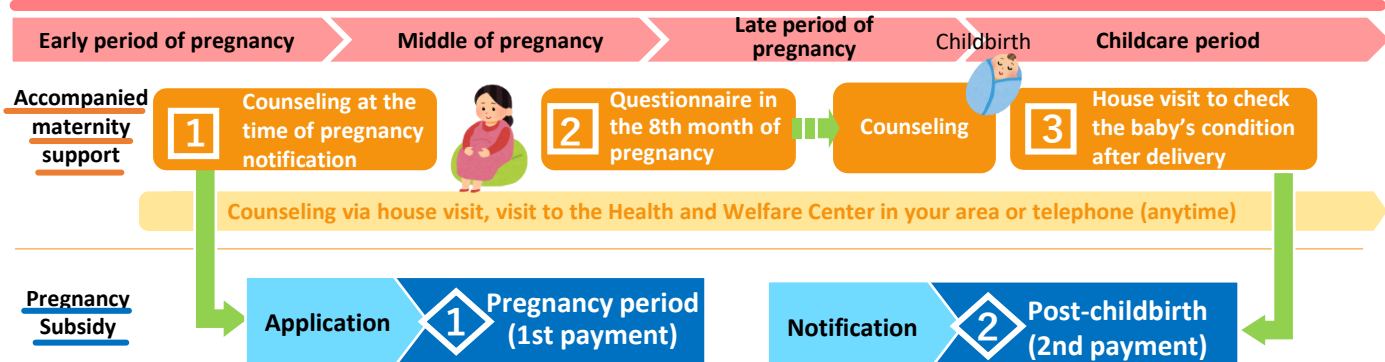
(Subsidy amount is determined according to the notification of the number of fetuses)

Notification deadline:

Within two years from the date eight weeks prior to the expected delivery date

*If your pregnancy is confirmed (by a doctor detecting the fetal heartbeat), you are eligible for both the first and second subsidy payments even if the pregnancy does not result in childbirth due to miscarriage, etc. The notification deadlines for the number of fetuses differ, so please contact us for details.

Important points

- ▶ The Pregnancy Subsidy is provided to women who became pregnant or gave birth on or after April 1, 2025.
- ▶ Please contact the section shown below if you moved to Kanazawa City after pregnancy notification or childbirth and you were not provided with the “Pregnancy Subsidy” before moving to Kanazawa City.
- ▶ Please contact the relevant section at the city hall of your new municipality if you move out of Kanazawa City without receiving the Pregnancy Subsidy.
- ▶ The “Support Benefits for Childbirth and Childcare” that have been provided to those who became pregnant or gave birth after April 1, 2022 became “Pregnancy Subsidy” from April 1, 2025. If you have not been provided with “Support Benefits for Childbirth and Childcare”, you are eligible for the “Pregnancy Subsidy” or “Childcare Subsidies” as a transitional measure. Please check Kanazawa City’s website.
