

Notification of School Lunch Fee Payment

Please submit the bank transfer application form to your bank and the school lunch application form to your child's school.

Please carefully read the following information about the school lunch service at junior high schools in Kanazawa City.

1. Forms to be submitted

(1) Bank transfer application form (automatic payment application form)

→ **Direct submission to your bank**

The Kanazawa City online bank transfer application service can be used at some banks.

*Please confirm the procedures of 2. Bank transfer application.

(2) School lunch application form → **Submission to your child's school (The form will be forwarded from the school to the city.)**

Once you complete the procedures, you will not need to do them again while your child is attending an elementary school or junior high school in Kanazawa City, including when starting junior high school or changing schools.

If your child will not use the school lunch service, you do not need to submit (1) or (2). (Those who have submitted a school lunch service cancellation form and requested "Canceling of a whole meal (every day)")

2. Bank transfer application

Fill out the bank transfer application form (3 copies) with a ballpoint pen (press strongly) and submit the form to a financial institution specified by Kanazawa City.

Online application via a PC or mobile phone is possible. Search the Internet with the keywords of 金沢市 web 口座振替 (Kanazawa City online bank transfer application). (Japanese site only)

3. Bank transfer dates (payment due dates) (5 times a year)

The following are the dates of bank transfer (payment due dates). If the day is a Saturday, Sunday or national holiday, the bank transfer date will be the following financial institution business day.

Period	1st	2nd	3rd	4th	5th
Bank transfer date	June 30	Aug. 31	Oct. 31	Jan. 4	March 31

- The annual scheduled amount and each transfer amount will be announced around June every year.
- The bank transfer amount for each period is [Amount per meal × Number of meals for one year] divided by five. From the 1st to 4th period, the amount is rounded up to the nearest 1,000 yen.

E.g.) $293\text{yen} \times 190 \text{ times} = 55,670\text{yen} \rightarrow 55,670 \div 5 = 11,134\text{yen}$

From the 1st to 4th period: 12,000yen each ($12,000\text{yen} \times 4$)

5th period: 7,670 円 ($55,670 \text{ 円} - 48,000 \text{ 円}$) (remaining amount)

- If a school event schedule is changed or a school lunch is not provided due to natural disaster or other reason, the difference will be applied in the billing amount for the fifth period.

4. School lunch fees

The school lunch fees are the actual costs for purchasing ingredients and other materials for school lunches. The following are the lunch fees per meal.

Junior high school: 293 yen per meal

If your child cannot eat part of a school lunch due to an allergy, etc., the corresponding amount will be reduced.

5. Suspension and Resumption of School Lunches

After application, school lunches will not be stopped unless the parent/guardian requests it. If you wish to suspend school lunch for more than 8 consecutive days due to illness or other reasons, please contact the school at least 3 days prior to the suspension (excluding Saturdays, Sundays, and holidays). Please note that in the event of a sudden absence, school lunch fees will be charged as food orders cannot be cancelled. Please contact the school at least 3 days in advance when resuming a suspended school lunch.

You do not need to submit the forms if your child enters a junior high school that is not a municipal school of Kanazawa City (national, prefectural or private schools), but please contact the school as soon as possible.
